## What is Mercy Multiplied?

Mercy Multiplied is a nonprofit Christian organization that helps young women break free from life-controlling issues, including eating disorders, self-harm, drug and alcohol addictions, unplanned pregnancy, depression, sexual abuse, and sex trafficking. Our residential program is voluntary, biblically based, and completely free of charge to young women ages 13-28. Our goal is to help residents permanently stop destructive cycles, discover purpose for their lives, and become productive and thriving individuals. Our outreach programs and resources are based on the same biblically based, life-transforming principles used by Mercy homes.

### **Mission Statement**

Mercy Multiplied exists to provide opportunities and resources to all to experience God's unconditional love, forgiveness, and life-transforming power.

## 2016 Accomplishments

- We expanded our Outreach, hosting 7 MPower workshops and 2 Freedom Experience events and equipping thousands of people with tools to effectively reach the hurting. We also expanded our website to include even more interactive and free resources, including podcasts and free downloads designed to address self-harm, eating disorders, drug and alcohol addictions, effects of sexual abuse and sex trafficking, depression, and unplanned pregnancy (MercyMultiplied.com/Resources).
- 2. We strengthened our development efforts by **refining and better utilizing the functions of our donor database** as well as refocusing our fundraising strategy to maximize development opportunities and minimize event production.
- 3. We saw a significant increase in the severity, complexity, and co-occurrence of the issues our applicants are facing. In response to this trend, **Mercy strengthened our residential program** by welcoming Dr. Brooke Keels as Executive Director of Counseling Services and by rolling out improved program operations guides and adjusting program delivery methods.

#### 2017 Goals

- 1. Develop additional protocols and counselor training to respond to the changes in the population we serve
- 2. Assess, adjust, and **simplify the application process** to allow for a faster intake timeline and more targeted applicant communications
- 3. **Expand our capital maintenance reserve fund** through targeted development efforts in order to ensure adequate funds are available for timely and appropriate planned repairs and replacements


