Mission Statement

Mercy Multiplied exists to provide opportunities and resources for all to experience God's unconditional love, forgiveness, and life-transforming power.

What We Do

Mercy has a residential program for women ages 13–32 and offers outpatient services to men (Louisiana only) and women aged 13 or older. These services are voluntary, biblically-based, and free-of-charge. Through our Outreach Services we provide multiple resources online and onsite designed to equip men and women of all ages to live free and stay free in Jesus Christ.

2021 Accomplishments

1. Our residential homes continue to provide essential services to our residents. Mercy's Intake Department fielded 10,711 contacts (phone calls, emails, texts) and processed more than 1,036 applications.
2. We celebrated the one-year anniversary of the first Mercy Center for Wellness and Counseling in West Monroe, LA and expanded our services to include men by hiring a male counselor. We have served over 100 people to date offering free outpatient counseling to men and women aged 13 and older.
3. We announced our intent to open a Center for Wellness and Counseling on the St. Louis property in 2022.
4. We hosted both virtual and in-person MPower workshops allowing people to attend from all over the world. We had attendees from Argentina, Brazil, Canada, Columbia, Costa Rica, Qatar, Dominican Republic, France, Germany, Haiti, India, Mexico, Morocco, New Zealand, Nigeria, Poland, and South Africa!
5. *Keys to Freedom* is available in 5 different languages and now can be accessed digitally. Multiple global churches are utilizing the *Keys to Freedom* curriculum in their in-person groups and e-groups. To date we know of 23 countries where *Keys to Freedom* groups are being held.

2022 Goals

1. Expand our reach through non-residential counseling through the Mercy Center for Wellness and Counseling by opening additional locations.
2. Increase Outreach Services through varied offerings of MPower and church support services.
3. Design, implement, and launch a short-term free-of-charge residential *Freedom Experience* for women 18 and older in our St. Louis location.

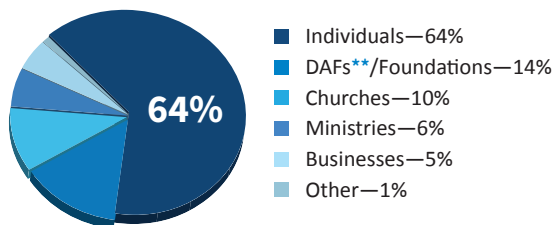

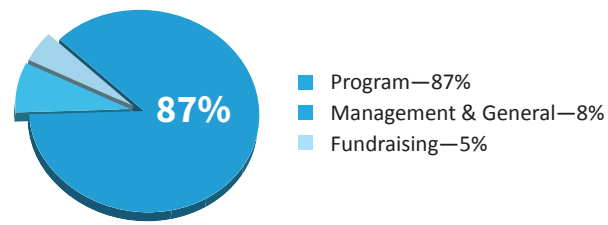
